The Central Pennsylvania Food Bank's mission is "Fighting hunger, improving lives, strengthening communities". Our organization began on the first World Food Day in 1981 and became a permanent operation on October 16, 1982. The Food Bank is a 501(c)3 non -profit organization registered as tax-exempt with the IRS and is a top financial performer within the Feeding America national network of more than 200 food banks. More than 75% of our funding comes from private donations and our Food Bank has a 4-star rating from Charity Navigator.

The Food Bank is a complex operation, comprised of 45 dedicated staff members, an engaged volunteer Board of Directors, 2,300 volunteers annually, warehouses in Harrisburg and Williamsport, and a fleet of 12 trucks. We provide efficient service to our emergency food network of over 600 pantries, soup kitchens, shelters, senior centers, and children's programs in 27 counties. In 2010, the Food Bank received 17.4 million pounds of donated food and distributed nearly 17.2 million pounds of food, the equivalent of more than 13.4 million meals, with an approximate wholesale value of \$27.5 million.
